



## ATTENTION BAC LOCAL 3 MEMBER OSHA INSTRUCTIONS

- 1. You must be a BAC Local 3 member in good standing.
- 2. Fill out the OSHA enrollment form completely. Forms can be found on our apprenticeship websites Tile @ www.nctijatc.org Brick/Marble/PCC/Terrazzo/Refractory @ www.bac3train.com
- 3. You must provide an accurate and working email address.
- 4. Enrollment forms should be emailed to the Apprenticeship Office, Tile Layers and Finishers <a href="msanchez@bac3tilejatc.com">msanchez@bac3tilejatc.com</a> and Brick/Marble/PCC/Terrazzo/Refractory <a href="msanchez@bac3train.com">olga@bac3train.com</a>
- 5. The Apprenticeship office will send you an email confirmation. Please check your spam folder. You must respond to the email to confirm you have a valid email address.
- 6. After your email is confirmed; you will receive an email from <a href="mailto:sholland@imtef.org">sholland@imtef.org</a> with instructions and a link to Red Vector who offers the on-line OSHA training.
- 7. Your username will be your email address and the password is your 6 digit I.U. number.
- 8. After completion, send your "Certificate of Completion" to the Apprenticeship Office. **You must do this to receive a stipend.**
- 9. After your Certificate is received by the Apprenticeship office. Your completion will be documented with the Apprenticeship office.
- 10. Proof of completion will then be sent to the Union Hall.
- 11. The Union Hall will request Stipend Checks from Benesys. Stipend checks do not come from the Apprenticeship office. Checks will be mailed to your address on file with Union Hall.
- 12. The stipend amount is \$199 for OSHA 10 and \$597 for OSHA 30. Apprentices in the masonry trades may only take OSHA 10. **Stipends are limited to \$597.00 per calendar year**
- 13. Your OSHA 10 or 30 card will be mailed directly to you within 4 to 6 weeks from the date you completed the course by (Kelly Services/Red Vector/Clicksafety).
